

**TOWN OF CUTLER ANNUAL TOWN MEETING
TUESDAY, APRIL 16, 2024 6:00 PM
CUTLER TOWN HALL

Presiding Chairperson was Martin Potter. Bobbie K Georgeson, Clerk, took notes. Total of 10 individuals were present. In attendance were Chair Martin Potter, Supervisors; Jim Hayward and Curt Jorgensen; Treasurer Terry Hayward; and Clerk Bobbie K. Georgeson. Others in attendance were: Charles Batten, Robert Fink, Bobby & Jade Shaw, and Jeff Shaw

1. CALL TO ORDER:
 - a. Chairperson Martin Potter, brought the Annual Meeting of the Town of Cutler to order at 6:00 pm, April 16, 2024 at the Cutler Town Hall.
 - b. Curt Jorgensen made a motion that a vote will be by voice. Jim Hayward seconded the motion. In favor – 10, Opposed – 0, Abstained – 0. Motion carried.
2. MINUTES: The minutes of April 18, 2023 were distributed. and accepted, no corrections or additions.
3. FINANCIAL REPORT: The 2023 Financial Report was presented and accepted. Bridges Repairs Loan Principal Balance as of 3/15/2024 is \$146,223.69. ARPA Balance on CD, as of 3/31/2024 is \$35,455.66 (interest included).
4. TOWN BUSINESS:
 - a. Jim made a motion to continue the Juneau County Highway Commission \$500.00 road petition matching funds. Curt seconded the motion. In favor-10, Opposed- 0, Abstained – 0. Motion carried.
 - b. Bob Fink made a motion to increase board wages: chairman to \$400/month, supervisors to \$350/month, treasurer to \$500/month, and clerk to \$1000/month. Charles Batten seconded. In favor-10, Opposed-0, Abstained – 0. Motion carried. Charles Batten made a motion to increase election workers pay: Chief to \$21.00 and poll worker to \$20.00 per hour. Bob Fink seconded. In favor-10, Opposed-0, Abstained-0. Motion carried. Bobbie made a plea to get people additional people trained, to relieve some pressure on current workers. Charles Batten made a motion to increase cleaning/maintenance rate of pay to \$25/hour, Bob seconded. In favor-10, Opposed-0, Abstained-0. Motion carried.
 - c. Curt nominated Lukus Woggon, as commissioner of noxious weeds. Jim seconded the motion. In favor-10, Opposed- 0, Abstained – 0. Motion carried. Martin appointed Lukus Woggon, as commissioner of noxious weeds. (WI Stats. 66.97)
 - d. Curt made a motion to keep the monthly Town Board Meeting on the second Monday of each month, at 6:00pm, at the Cutler Town Hall N10846 2nd Ave, Camp Douglas, WI, except April Meeting. Jim seconded the motion. In favor-10, Opposed- 0, Abstained - 0. Motion carried.
 - e. Curt made a motion to post the Town Board Meeting Notices on website, along with the postings at town hall, Eagles Nest, and Bethel church. If we need to publish, the Juneau County Star-Times is the newspaper we will use. Jim seconded the motion. In favor-10, Opposed- 0, Abstained – 0. Motion carried.
 - f. Curt made a motion that the 2025 Annual Town Meeting be held on Tuesday, April 15, 2025, at 6:00pm at the Cutler Town Hall N10846 2nd Ave, Camp Douglas, WI. Jim seconded the motion. In favor – 10, Opposed- 0, Abstained – 0. Motion carried.
5. MEETING ADJOURNED: Curt made a motion to adjourn the annual meeting. Jim seconded the motion. All in favor-10, opposed- 0, Abstained 0. Motion carried.
